Completion Date. Omni Media Group and the Client must work together to complete the Web Design Project in a timely manner. We agree to work expeditiously to complete the Web Design Project no later than 14 days from the signing of this contract. The client must supply Omni Media Group with all content needed. (Text, Graphics and Photography) for this Web Design Project. Omni allows 3 days from the date of this agreement to provide the content. If the client does not provide the content and the 14 days to complete the project expire, the client will still be liable for the balance due and will be charged an additional continuation fee of 10% of the total agreement price. These charges will begin on the 15th day. The continuation fee of 10% will be assessed each week until the website is completed.
