Copyrights and Trademarks. The Client unconditionally guarantees that any elements of text, graphics, photos, designs, trademarks, or other artwork furnished to Omni Media Group for inclusion in the Web Design Project are owned by the Client, or that the Client has permission from the rightful owner to use each of these elements, and will hold harmless, protect, indemnify and defend Omni Media Group from any liability (including attorney's fees and court costs), including any claim or suit, threatened or actual, arising from the use of such elements furnished by the Client.

Completion Date. Omni Media Group and the Client must work together to complete the Web Design Project in a timely manner. We agree to work expeditiously to complete the Web Design Project no later than 14 days from the signing of this contract. The client must supply Omni Media Group with all content needed. (Text, Graphics and Photography) for this Web Design Project. Omni allows 7 days from the date of this agreement to provide the content. If the client does not provide the content and the 14 days to complete the project expire, the client will still be liable for the balance due and will be charged an additional continuation fee of 10% of the total agreement price. These charges will begin on the 15th day. The continuation fee of 10% will be assessed each week until the project is completed and final payment is received.

Project Delivery. The completed web design project will be published to the Client's hosting service after receipt of the final payment.

Payments. Payments must be made promptly based on the terms of this contract. Omni Media Group reserves the right to remove any Web Design Project from viewing on the Internet until final payment is made.

Payment Schedule. Payment for services provided hereby shall be made in accordance with the conditions contained in this contract.
